11/02/2021—Romel Santiago Garcia, 31, of Summit was arrested and charged with driving while intoxicated. Mr. Santiago Garcia was processed and released with a pending court date.

11/02/2021—At 1439 hours a report was taken for an attempted burglary or theft of a motor vehicle parked at a Fernwood Road residence. The incident occurred just prior to contacting police when the caller witnessed a male attempting to enter a parked 2020 Land Rover. The male is described as a thin male wearing a black mask, black shirt, and black sweatpants. Upon confronting the male, he ran down the driveway and vacated the area.
