### Weekly blotter November 20 to December 3

11/20/2023—At 0702 hours a report was taken for a burglary that occurred at an Industrial Place business. The victim stated an unknown individual entered the business through an unsecured window and once they were inside the building a motion sensor activated the alarm system that alerted police. At the time of the report nothing was taken or rummaged through.

11/20/2023—At 0932 hours a report was taken for a theft that occurred at a Norwood Avenue residence. The victim stated someone entered an unsecured vehicle sometime during overnight hours. Taken was an Apple USB-C charging cable, valued at \$20.

11/21/2023—At 1616 hours a report was taken for a theft that occurred at a Morris Avenue business. The victim stated security footage showed an unknown individual taking a beverage from a refrigerator and leaving without purchasing it. The individual in question is described as a white male with dark facial hair wearing a blue winter jacket and blue jeans. The value of the beverage was \$5.

jacket and dark pants was seen putting merchandise in a bag and exiting the business without purchasing the merchandise, valued at \$18.

11/29/2023—At 1534 hours a report was taken for a theft that occurred at a Knob Hill Drive residence. The victim stated that multiple packages were taken from the residence during the overnight hours. The total amount of the theft was approximately \$100.

11/30/2023—At 1959 hours a report was taken for an attempted burglary to a residence on Londonderry Way. The attempt was aborted when the suspect attempted to force open a rear window to the residence and an alarm sounded. The suspect then fled the area.
