# GENERAL INFORMATION ABOUT LICENSING DOGS & CATS\*

State law requires the licensing of every dog that has either reached the age of seven months or has a set of permanent teeth. By local ordinance, all cats are required to be licensed at seven months.

Licenses must be obtained from the municipality in which the animal resides. However, a current license from another New Jersey municipality is accepted as compliance. When that license expires the animal must be licensed in Summit. All animals must be registered with the Summit Health Department within ten days of moving to Summit or reaching licensing age.

The City of Summit licensing year is June 1<sup>st</sup> through May 31<sup>st</sup>. Licenses must be renewed annually.

Dog and cat license applications can be obtained on our website at www.cityofsummit.org or at the Summit Health Department.

If the animal is spayed or neutered, a certificate from the veterinarian must accompany the initial application.

Proof of rabies vaccination must also accompany the application. According to State regulation, the vaccination certificate must show that the vaccination is valid for ten full months of the licensing year; therefore the vaccination must be good through March 31 of the following year.

For medical reasons, some dogs and cats are given a one-year vaccination that may not cover the registration period. Call the Summit Health Department for guidance in these cases.

As a courtesy, the City of Summit may send out license renewal notices. It is the responsibility of the resident to renew their pet(s) license by May 31 of each year. If May 31 falls on a weekend, the license must be renewed no later than the next business day. If received after the renewal deadline, a late fee will be assessed. There is no late fee for first time licensing.

#### Remember:

- ★ Licensing period is from June 1<sup>st</sup> through May 31<sup>st</sup> of each year. The Health Department must receive renewals by May 31<sup>st</sup>. Renewals received after May 31<sup>st</sup> will incur at late fee of \$10.00 per pet
- ★ Proof of rabies vaccination is required in order to purchase a license and must be valid through March 31<sup>st</sup> of the following year
- \* When purchasing a license for the first time, proof is required if pet has been neutered/spayed
- \* All dogs and cats over the age of seven (7) months must be licensed
- ★ License fee is \$15.00 for altered cats and dogs, and \$21.00 for non-altered cats and dogs.
- ★ If a licensed animal is deceased please notify the Health Department, in writing, so we can update our records
- ★ Licenses are not transferable between animals
- ★ If a license/tag is lost, there will be a \$10.00 duplicate license fee.
