Once registered, you will need to upload the completed application and a copy of your vehicle registration showing your Summit address. If the vehicle is leased include the insurance card showing the Summit address.

THE PERMIT IS DIGITAL BY YOUR LICENSE PLATE

PLEASE READ THE FOLLOWING CAREFULLY AND SIGN BELOW:

1. The overnight period covers the hours from 3:00 p.m. to 8:00 a.m. After 8:00 a.m. (Monday - Friday), I understand that my vehicle must be removed from the lot/street or moved to a proper lot and that I am responsible for the daytime parking fees except for #3 below.
2. I understand if I choose to park in a lot/street above with an * next to it I will have my car moved by 8a.m. Saturday morning or I will be ticketed.
3. If you are parked (Monday - Friday only) in the Maple Street K-Lot, Tier Garage or Post Office Lots and you are NOT a "Downtown Employee", your vehicle must be removed from the lot or you will be ticketed. These are "Employee Only" daytime parking lots.
4. The online permitting system will automatically charge the credit card on file

The quarters are as follows:

1st Quarter - January 1st - March 31st
2nd Quarter - April 1st - June 30th

3rd Quarter - July 1st - September 30th

4th Quarter - October 1st - December 31st

5. In the event of a snowfall prediction greater than 1", I agree to park in the BROAD STREET PARKING GARAGE or TIER GARAGE to allow for proper snowplowing of the overnight lots.
 - a. I understand that the City of Summit is not responsible if I do not move my vehicle to the Broad Street Garage or Tier Garage and the vehicle gets plowed in.
6. The quarterly fee is **\$100.00 (\$75-seniors)** per vehicle.
7. If I no longer require the permit within a current quarter, I will notify the City in writing.
8. I have read and understand the above regulations concerning overnight parking and understand that if they are not adhered to, I would be subject to appropriate penalties
9. Once your request is in the online system is may take up to 48 hours to review and process

ON- STREET OVERNIGHT PARKING

1. If you reside in one of the listed complexes, you are eligible to park on the approved street listed below.
2. You are permitted to park from 3 pm to 8 am.
3. The vehicle must be moved each morning if the street has hourly time-limited parking.
4. At no time, if there is a forecast of snow greater than 1", may a vehicle be left on any street in the City of Summit. All streets must be clear of vehicles for snow plowing. You will have to move your vehicle to BROAD STREET PARKING GARAGE or TIER GARAGE to allow for proper snowplowing.
