

**AUTHORIZE CONTRACT EXECUTION –  
MARKETING AND TRANSPORTATION OF  
RECYCLING MATERIALS MARCH 1, 2022  
THROUGH DECEMBER 31, 2023**

WHEREAS, under the procedures for Competitive Contracting pursuant to N.J.S.A. 40A:11-4.1 et seq., the City of Summit received one proposal from Giordano Company, Inc. for the Marketing and Transportation of Recycling Materials on January 11, 2022, for a twenty-two (22) month term March 1, 2022 through December 31, 2023, which were based percentage of published market prices and including floor prices per ton for each of the following commodities:

1. Dual Stream – Fiber Material
  - a. Delivered by City to buyer facility using City containers
  - b. Picked up by buyer at City facility using buyer's containers
  - c. Picked up & returned by buyer at City facility using City containers
2. Dual Stream – Commingled Containers
  - a. Delivered by City to buyer facility using City containers
  - b. Picked up by buyer at City facility using buyer's containers
3. Single Stream Material
  - a. Delivered by City to buyer facility using City containers
  - b. Picked up by buyer at City facility using buyer's containers
4. Old Corrugated Cardboard – picked up by City from CRBD and resident drop-off at Transfer Station and delivered by City to buyer facility

WHEREAS, in a memo from the Superintendent of Public Works, upon evaluation of the proposals and options, recommends awarding items 1(b), 2(b), 3(b), and 4 to Giordano Company, Inc., and


WHEREAS, funds will be certified from account #X-01-26-308-000-200 upon inclusion in and adoption of each respective years' operating budget.

NOW, THEREFORE, BE IT RESOLVED BY THE COMMON COUNCIL OF THE CITY OF SUMMIT:

1. That the Mayor and the City Clerk are hereby authorized and directed to execute an agreement with Giordano Company, Inc., 142 Frelinghuysen Avenue, Newark, NJ 07114 for items 1(b), 2(b), 3(b), and 4 as described above.
2. That this contract is awarded, without competitive bidding as Competitive Contracting in accordance with N.J.S.A. 40A:11-4.1 et seq.
3. That Giordano Company shall be subject to meeting the requirements of N.J.S.A. 10:5-31 et seq. and N.J.A.C. 17:27 (Affirmative Action), N.J.S.A. 52:32-44 (Business Registration), and the City's insurance requirements.
4. A notice of this action shall be printed in the Union County Local Source.
