The system will verify whether your business is properly registered and if so, generate an online, printable Business Registration Certificate.

**If you are not properly registered with the State of New Jersey**, you must complete the process, which can be done via regular mail or online at <http://www.nj.gov/treasury/revenue/busregcert.shtml>. There is a link for instructions for online submission on the main page. Online applications are supposedly processed within 2 to 3 days.
